## OUI Inc.'s Smart Eye Camera expands to Cambodia!

OUI Inc.'s VP of Global Business, Shintaro Nakayama, travelled to Cambodia to implement our Smart Eye Camera first-hand into clinics.



In May 2022, Shintaro Nakayama, Vice President of Global Business of OUI Corporation, visited Cambodia following Vietnam to introduce the "Smart Eye Camera" directly to clinics.

Angkor Hospital for Children is a hospital that provides free and high quality medical services for poor children in Cambodia, and has been supported by doctors and medical staff from all over the world who have volunteered since its inception. In addition to its commitment to research, the hospital also conducts school examinations in the vicinity. We screened a total of 78 students and teachers for strabismus and cataracts at an elementary school in the suburbs of Siem Reap using the

Smart Eye Camera. None of the ophthalmology staff goes to the school checkups. It was the outreach team that went, and they were people who did not know ophthalmology, but we were able to make a very clear diagnosis using the Smart Eye Camera.

At Khmer Soviet Friendship Hospital, a general hospital of the Public in Phnom Penh, we conducted an eye screening demonstration using the Smart Eye Camera. Everyone was able to shoot video well.

This expansion into Cambodia was fruitful, and many clinics have installed the Smart Eye Camera, with more to come. We will continue to introduce the system to Cambodia and various other countries in the future.
